ADDED AIMS AND OBJECTIVES

- 1. The Ashrafia Educational Society is running School /Name Darul Uloom Ashrafia at Kollampally
- 2. To establish Mobile Dispensaries and Hospitals for Tribal People, Schedule Cast Peoples and other weaker Section people
- 3. To run rural emergency health transport system
- 4. To undertake all the Health needs of the poor people through Health service and Health education Programmes etc. like Free Health Checkup camps, Health Canters, Family Planning and AIDS awareness programmes, Counseling Centres etc.
- 5. To establish and manage Girls Hostiles, Kasturba Gandhi Balika Vidyalaya (KGBV) Short Stay Homes for Women and Girls in distress.
- 6. To Construction of Hostel Building for Working Women with Day Care Centres for women and children.
- 7. To establish and manage SWADHAR Centres Help Line Centres etc.
- 8. To start support to training and employment Programme (STEP)
- 9. Setting up employment and income generating training cum production units for women and all other women activies under NORAD Scheme.
- 10. To Establish and manage Jana Shikshan Sansthan (JSS)
- 11. To run Counselling Centres.
- 12. To under take all Natural Resource Management Programmes and other schemes of CAPART.
- 13. To organize Adult Education, Non Formal Education, Child Labour Camps / Hostels Residential Bridge Course.
- 14. Centres, Non-residential Bridge course centers for child labour, drop out children an never enrolled children, etc. and all other child development programs.
- 15. To undertake community infrastructures like Tanks, Canals, Check Dams and other irrigation Works, Digging of Wells, Buildings, Roads, Bala Mandirs, Mahila Sadans, Youth

- Clubs, Hospitals, Youga Centres, Schools, Libraries, Teachers, Quarters, Community Halls. Houses for weaker and Economically Backward Sections and SC/ST Peoples.
- 16. To construct model villages organize Model Agriculture Farms. Nurseries and help the poor farmers to popularize innoventions and technology transfers fro adoption by common man.
- 17. To take up joint forest management
- 18. To undertake studies, research project and publications of literature, reports on problems relating to the objects / activities.
- 19. To establish agro-sevice centers and agricultural training centers and organize short-term courses for agriculturists and agricultural labourers.
- 20. To establish Krishi Vigyan Kendras (KVK) appropriate rural technology centers and production-cum-training centers in order to provide training and to disseminate latest agricultural practices to farming community and farm labourers and organize diploma or degree courses in agricultural related activates for youth.
- 21. To develop and implement community based low –cost comprehensive health care programmes for mothers, children and disabled persons and to organize special / general medical camps, and disabled awareness camps.
- 22. To train health and development workers, special educators and social workers drawn from the governmental and non government sectors.
- 23. To organize Sishu Vihars, Bala Sanghams (children clubs) and Mahila Mandals and youth Clubs and conducting training in Leadership and HumanResource Development.
- 24. To conduct educational tours for the children, youth, men and women of Indian origin with the country as well as abroad.
- 25. To co-ordinate with NSS, NCC and other similar organizations who ar workers for the development and welfare of the youths.
- 26. To organize women into effective self help groups (SHG) DWACRA groups, who will initiate group action programmes for women and child welfare. Economic development by undrtaking income generating activities from the Government organizations, financial institutions, Rashtriya Mahila Kosh, National Minorities Development Finance Corporation Ltd. Organizations to promote this activity.

- 27. To increase income level of poor families by organize women into effective groups and to enhance their capabilities by upgading their skills and to act as catalyst with backward and forward linkages.
- 28. To disseminate information on diet and nutrition, and to promote nutrition education in schools through mass media, publishing journals, pamphlets an other media.
- 29. To investigate means to offset existing deficiencies in the pattern of prodution and distribution of food and to ensure the wholesomeness and nutritive value of food sold for public consumption and to establish nutrition rehabilitation centers for those who are suffering with nutritive deficiences
- 30. Highlight an focus the importance of national integration by organizing youth camps, national integration by organizing youth camps, national integration camps seminars, workshops conferences, meetings, theme camps debates and discussion.
- 31. To undertake and organize study courses, lectures, meetings, conferences, seminars, discussions, exhibitions and the like to promote the objectives of.
- 32. To run all catergories schools, secondary, higher and technical educational institutions, colleges of all categories for the benefit of the people
- 33. To assist organize and undertake the disaster management programmes relief, rehabilitation and reconstructions activities for the people, who ar affected by natural calamities like floods, cyclones, droughts and earth quakes any where in India.
- 34. To organize homes fo the old aged and physically handicapped mentally retarded, deaf and dumb and other disabled leprosy affected persons through integrated community based and homes based intervention programmes
- 35. To conduct surveys on disabled persons, physically handicapped, mentally handicapped and street children and to provide them day care centers, residential homes and to institute as SAHAYA village with an integrated services for the benefit of these sections and the street children.
- 36. To establish homes/hostel and provide other integrated services for the children in need of care i.e. street children child labourers, Rag pickers etc. and to make them useful citizens.
- 37. To act as a link between the central an state governments and other appropriate agencies for formulation and execution of projects. Programmes and schemes for integrated rural

- development and to accept necessary grants or funds for fulfilling these activities.
- 38. To set up cottage, small scale industries an viable medium industries for the benefit of rural masses on no loss an no profit basis.
- 39. To raise funds (in cash or in kind), subscriptions, property of any kind from the people, institutions, organizations and agencies.
- 40. To acquire by gift, purchase exchage,lese or hire or otherwise howsoever any lands buildings, easements, and any other property immovable for nay estate or interest for furtherance of all or nay objectives.
- 41. To accept donations and assistance for the group on behalf of the implementing agencies from the government and foreign donors and to furnish imformation regarding the physical and financial progress of the schemes/programmes to the concerned organizations.
- 42. To borrow and raise funds with or without security in any manner as the society may think fit and to repay the same either from individuals, financial institution/any Bank (like NABARD, SIDBI, other commercial banks) or government departments / organizations like Rashtriya Mahila Kosh, National Minority Development Finance Corportion National Handicapped Finance Corporation etc. and other agencies.
- 43. To draw, make accept, endorse and discount cheques notes or other negotiable instruments to the purpose of activities.
- 44. To sell, manage, transfer, exchange mortgage, lease dispose off or otherwise deal with any property whatsoever belonging to in the interest of the organization and people.
- 45. To maintain accounts of all receipts and expenditures of and correctness of accounts and balance sheet which a charted accountant shall audit at least once in a year.
- 46. To help and assist habitat development and promotion for economically weaker sections, downtrodden in the urban and rural areas with the beneficiary participation.
- 47. To encourage art and cultural activities through drams, dances and literacy conferences and to assist the organization in construction on open-air theaters in rural and urban slums.
- 48. To propagate the prohibition ideology through de-addiction campaigns, workshops, seminars, including cultural activities

- 49. To work for the integrated development of the minority communities SC/ST and Backward communities in country.
- 50. To do all such other lawful acts, deeds or things, either alone or in conjunction with other organizations as are incidental or conducive to attainment the objectives of
- 51. To deposit the funds of not immediately required in deposit with nationalized bank or in any securities authorized under the investment of the funds of the organization shall be in accordance with the provision of (section 13(i) (d)) read with section 11 (5) of the income tax act 1961.
- 52. To distribute the assets of the society in the event of dissolution / winding up to the society with similar activates that are registered under the society registration act 2001. Which is also registered with income tax act under 12A and 80G

STATUS OF THE SOCIETY

- a. The Society shall function as a non-secular, non-political one and the benefits of the society are open to all sections of the needy people irrespective of cast, creed, religion and sex.
- b. All the amendments to the memorandum of Association of the organization will be carried out by way of resolution in the executive body meeting attended by at lease 2/3rd members.
- c. All the Amendments to the memorandum of association of the Organization will be carried out only with the prior approval of the commissioner of income tax.
- d. The income of the funds of the society will be solely utilized towards the objectives and no portion of it will be used for as payments to the trustees or members by way of profits or in any other manner.
- e. The society formed under the above title shall be irrevocable
- f. The activities of the organization shall be carried out anywhere in India.

RULES AND REGULATIONS OF THE SOCIETY

- I. NAME OF THE SOCIETY; ASHRAFIA EDUCATIONAL SOCIETY IN THESE RULES AND REGULATIONS
- **II. OFFICE**: its head quarters shall be at Kollampally village of NarayanpethMandal. Till otherwise decded upon by the General Body.
- **III. JURISDICTION**: Its jurisdiction shall extent to the whole of the Andhra Pardesh.

IV. MEMBERSHIP

- 1) The society shall admit two kinds of members Ordinary members and institutional members. The period of membership shall be financial year
- 2) Ordinary membership shall be opened to those who pay Rs.10/- as Annual Subscription and who in the opinion committee subscribe to the objectives of The society and who are eighteen years of above.
- 3) Institutional membership shall be opened to organizations and association or Unions who in the opinion of the committee subscribe to the objectives of the society and who pay enroll themselves at a subscription fee of Rs. 50/- per annum.
- 4) Annual dues or members shall be for the Calendar year which shall also be the Financial year and shall be payable by January 10th of the each year
- 5) Executive Committee shall be right to remove any members for active's Prejudicial ot the objectives of there societies after giving such a member an opportunity to show against removal.

V. ANNUAL GENERAL BODY MEETING

- 1) There shall be an annual meeting of the Society convened after 10 clear days notice. The Notice shall contain the time and place of the Annual meeting and also the purpose for which the meeting poposed to be convened.
- The annual Meeting shall be held preferably 10th of the each year in the month of Januay In that meeting the annual report of the Government body together with a Statements of accounts. Duly certified by an auditor shall be presented and passed.
- 3) The Governing Body inclussive of the office-bearers, shall be elected by the General Body, for a three years term and no members of the Governing Body shall hold office for more than two successive terms. Those elected shall enter on their duties hence forth and shall continue in

officeuntill their successors are elected

4) The General Body shall appoint the Auditor of the Society for the coming year

VI. FUNTIONS:

Executive Body: The exact member of executive body including office bearers are seven(7)

A. PRESIDENT

- 1) He shall preside at all meetings of the Governing Body and General Body. Any ruling given by him at such meetings shall be final
- 2) He shall be the authority to issue any statement in the name of the Society
- 3) He shall have the powers to appont staff and other workers and has also powers to retrench.
- 4) He has power to take disciplineary action against the staff or workers as to keep up the discipline and orer of the society.
- 5) The President has power to correspondent, negotiate or enter into contract with Government Departments, private persons in our country or foreign countries in the interest of the society.

B. VICE PRESIDENT:

- 1. He shall act as President during the absence of the President and shall exercise during such period all the powers of the President.
- 2. He shall also exercise power of the President delegated to him

C. SECRETARY:

1. The secretary shall convene, coordinate and conduct all meetings of the society in consultation with the President.

JOINT SECRETARY

1. He will act as Secretary and perform his during the absence of the Secretary.

D. TREASURER:

- 1. The Treasurer will operate all banking transactions and shall be responsible for all financial Matters.
- The treasurer shall maintain a joint account in any bank approve by the executive committee and shall maintain accounts receipts, vouchers etc. as required for a counting the cash receipts and payments.

3. MEMBERS:

The two members maintained by the President shall be used for any type of executive work as directed by the President.

VII. QUORUM: (For General Body executive Committee Meetings)

The quorum of the General Body and Executive Committee Meetings shall be $2/3^{rd}$ of the Members. There solutions of the General Body / Executive Committee shall stand or unpassed if it is voted by a simple majority.

VIII. SUITS AND LEGAL PROCEEDINGS:

All suits and other legal proceedings initiated by the Society shall be constituted and prosecuted in the name of the Society by the President. The President may sue or be used in the nme of the society and shall be represented by the President.

IX. FUNDS:

- 1) Aquire or purchase. Lease, mortagage, will, gift Grant, Legacy, Be queth, Exchange, right Previlage or otherwise from any person, Company, Society, Government, Institution, Organisation or any Body whatsoever, movable or immovable properties of all description deemed, necessary or useful for any purpose of the Society.
- 2) Errect buildings or structure, whatsoever to further any purpose or purposes of the society and to maintain develop improve after repair, demolish or reconstruct the same and or any portion thereof.
- 3) Take or receive any Gifts, whether money or property movable, immovable, conditions in the form of debentures. Stocks, spares or securities in any company or society whether incorporated or not or whether by Gifts by a person living or by legacy bequosts will or donations and whether subject to any special trust or for works connected therewith and to take steps for the securing the such contributions for funds as from time to time be deemed expendient.
- 4) The President shall have powers with prior permission of the executive committee to rise funds by way of donations, subscriptions or benefit shows and such others
- 5) All the funds of the society shall be deposited in State Bank of India, Narayanpeth Branch or any other approved bank of Joint Account.
- 6) The funds of the society shall be utilised for the benefit and imporvement of the society and shall not be otherwise utilised.
- 7) The funds or portions of it shall not be paid or transferred directly or indirectly to by any of its members by any means.
- 8) The president shall be liable for any loss incurred.

X. AMENDMENTS:

This constitution may be altered or amended by a vote of not less than $2/3^{rd}$ of the members present at any meeting of the society provided previous intimation of such alterations or amendments have been given to the members by the notice convening the meeting.

XI WINDING -UP

In case the society has to be wound-up the property and funds of the society that will remain after Full satisfaction of all the liabilities of the society will be transferred to some other Institution with similar aims and objectives.
