RULES AND REGULATIONS OF THE SOCIETY

I. NAME OF THE SOCIETY ASHRAFIA EDUCATIONAL SOCIETY IN THESE RULES AND REGULATIONS.

II. OFFICE; its head quarters shall be at kollampally village of Narayanpet Mandal. Till otherwise decided upon by the General Body.

III. JURISDICTION; Its jurisdiction shall extent to the whole of the Andhra Pradesh.

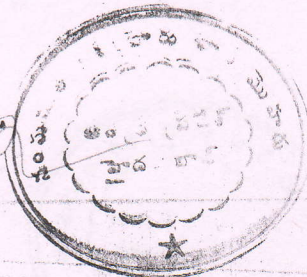
IV MEMBERSHIP;

- 1) The society shall admit two kinds of members - Ordinary members and institutional members. The period of membership shall be financial year.
- 2) Ordinary membership shall be opened to those who pay Rs. 10/- as Annual Subscription and who in the opinion committee- subscribe to the objectives of The society and who are eighteen years of above.
3. Institutional membership shall be opened to organizations and association or Unions who in the opinion of the executive committee subscribe to the objectives of the society and who pay enroll themselves at a subscription fee Of RS. 50/- per annum.
4. Annual dues or members shall be for the Calendar year which shall also be the Financial year and shall be payable by January 10th of the each year.
- 5) Executive Committee shall be right to remove any members for active's Prejudicial to the objectives of there societies after giving such a member an opportunity to show against removal.

V. ANNUAL GENERAL BODY MEETING;

- 1) There shall be an annual meeting of the Society convened after 10 clear days notice. The notice shall contain the time and place of the Annual Meeting and also the purpose for which the meeting proposed to be convened.
- 2) The annual Meeting shall be held . preferably 10th of the each year in the month of January. In that meefing the annual report of the Government body together with a Statements of accounts. Duly certified by an auditor shall be presented and passed.

- 3) The Governing Body, inclusive of the office-bearers, shall be elected by the (General Body, for a three years term and no members of the Governing Body shall hold office for more than two successive terms. Those elected shall enter on their duties hence forth and shall continue in office until their successors are elected.
- 4) The General Body shall appoint the Auditor of the Society for the coming year.

VI. FUNCTIONS:

Executive Body: The exact member of executive body including office bearers are seven (7).

A. PRESIDENT:

- 1) He shall preside at all meetings of the Governing Body and General Body. Any ruling given by him at such meetings shall be final.
- 2) He shall be the authority to issue any statement in the name of the Society.
- 3) He shall have the powers to appoint staff and other workers and has also powers to retrench.
- 4) He has power to take disciplinary action against the staff or workers as to keep up the discipline and order of the society.
- 5) The President has power to correspond, negotiate or enter into contract with Government Departments, private persons in our country or foreign countries in the interest of the society.

B. VICE PRESIDENT:

- 1) He shall act as President during the absence of the president and shall exercise during such period all the powers of the president.
- 2) He shall also exercise power of the President delegated to him.

C. SECRETARY:

- 1) The secretary shall convene, co-ordinate and conduct all meetings of the society in consultation with the President.

JOINT SECRETARY:

1. He will act as Secretary and perform his during the absence of the Secretary.

D. TREASURER:

- 1) The Treasurer will operate all banking transactions and shall be responsible for all financial matters.
- 2) The treasurer shall maintain a joint account in any bank approved by the executive committee and shall maintain accounts, receipts, vouchers etc., as required for a counting the cash receipts and payments.

3) MEMBERS:

The two members maintained by the President shall be used for any type of executive work as directed by the President.

VII. QUORUM: (For General Body executive Committee Meetings)

The quorum of the General Body and Executive Committee Meetings shall be 2/3rd of the members. There solutions of the General Body/Executive Committee shall stand or unpassed if it is voted by a simple majority.

VII. SUITS AND LEGAL PROCEEDINGS:

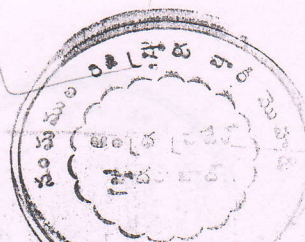
All suits and other legal proceedings initiated by the Society shall be constituted and prosecuted in the name of the Society by the President. The President may sue or be used in the name of the society and shall be represented by the President.

IX. FUNDS:

- 1) Acquire or purchase, lease, mortgage, will, gift Grant, Legacy, Bequeth, Exchange, right previlage or otherwise from any person, Company, Society, Government, Institution, Organisation or any Body whatsoever, movable or immovable properties of all description deemed, necessary or useful for any purpose of the Society.
- 2) Erect buildings or structure, whatsoever to further any purpose or purposes of the society and to maintain develop improve after repair, demolish or reconstruct the same and .or any portion thereof.
- 3) Take or receive any Gifts, whether money or property movable, im movable, conditions in the form of adventures. Stocks, spares or securities in any company or society whether incorporated or not or

whether by Gifts by a person living or by legacy bequests will or donations and whether subject to any special trust or for works connected therewith and to take steps for the securing the such contributions for funds as from time to time be deemed expedient.

- 4) The president shall have powers with prior permission of the executive committee to raise funds by way of donations, subscriptions or benefit shows and such others.
- 5) All the funds of the society shall be deposited in State Bank of India, Narayanpet Branch or any other approved bank of Joint Account.
- 6) The funds of the society shall be utilised for the benefit and improvement of the society and shall not be otherwise utilised.
- 7) The funds or portions of it shall not be paid or transferred, directly or indirectly to by any of its members by any means.
- 8) The president shall be liable for any loss incurred.

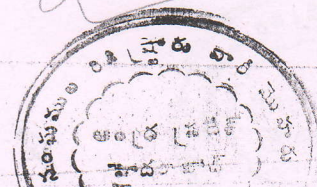
X. AMENDMENTS:

This constitution may be altered or amended by a vote of not less than 2/3rd of the members present at any meeting of the society provided previous intimation of such alterations or amendments have been given to the members by the notice convening the meeting.

XI. WINDING-UP:

In case the society has to be wound-up the property and funds of the society that will remain after full satisfaction of all the liabilities of the society will be transferred to some other institution with similar aims and objectives.

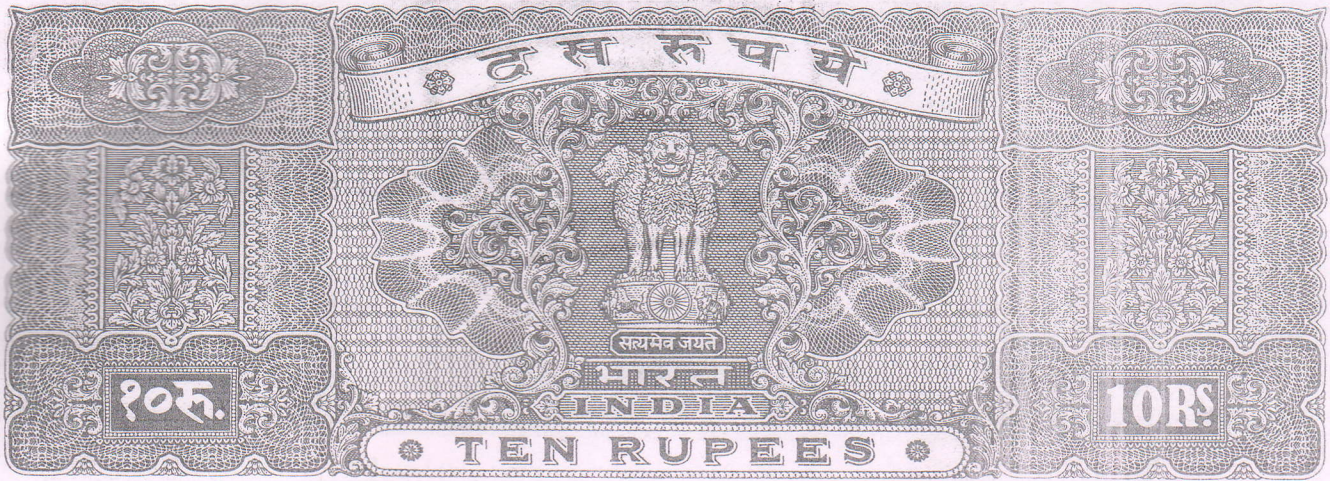
